	More than 6 months before the start of the stay			
	Cancellation	The customer receives a refund for the total amount of the reservation.		
	Modification	For any modification resulting in a total balance <b>lower</b> than the original amount billed, the first modification is free of charge. A modification fee of \$40 is applied to the second modification as well as to subsequent ones. Any modification resulting in a total balance <b>greater</b> than the original amount billed is free of charge.		
	Less than 6 months and up to 1 month before the start of the stay			
For the  Mûs prospector camps,  Atihk" and Amisk" cabins,  Nicik" camps  and Mwak" floating cabins	Cancellation	The customer receives a refund for the total amount of the reservation less a 30% cancellation fee.
